<b>What is the overall deductible?</b>	\$0.	See the Common Medical Events chart below for your costs for services this plan covers.
<b>Are there services covered before you meet your deductible?</b>	No.	You will have to meet the deductible before the plan pays for any services.
<b>Are there other deductibles for specific services?</b>	Yes. For <u>prescription drugs</u> - Individual \$100 / Family \$300. There are no other specific <u>deductibles</u> .	You must pay all of the costs for these services up to the specific <u>deductible</u> amount before this plan begins to pay for these services.
<b>What is the out-of-pocket limit for this plan?</b>	<u>Network</u> : Individual \$3,500 / Family \$8,750.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this plan, they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.
